I am writing you in regards to Report 2023-86 Nickel Beach Parking By-law Amendments as there are still neighbourhood concerns that need to be addressed. First of all what safeguards will be put in place to ensure contractors working in the area at residents homes will not be ticketed? Many residents are not home when contractors arrive and not all of them are local! How about the issue of unexpected guests or company coming to visit after the hours of operation when a guest pass can be issued by the city? What is the city doing to accommodate affected residents?

Why was no canvassing done in Zone 4 and was the entire Zone 3 covered during the single day of door to door canvassing? Many residents still do not understand how this new By-law and parking changes are affecting them. Why is the East side of Davis St. not included in the new parking By-law amendments: Will this not cause more confusion to residents and visitors?

The parking and By-law changes are being created and passed so quickly through council without the proper communication, engagement and notification to all the affected residents. How will the city ensure with just under two weeks left till this By-law goes into effect that the affected residents will be properly notified?

By-law No. 7006/44/22 - a by-law to establish a permitting system for the parking of vehicles on designated highways and parking lots in the City of Port Colborne.

By-law No.89-2000 - a by-law regulating traffic and parking on city roads.

By-law No. 4310/146/02 – a by-law prescribing on and off-street parking for persons with disabilities within the City of Port Colborne.

Whereas at its meeting of May 9, 2023, the Council of The Corporation of the City of Port Colborne Council approved the recommendations of the Corporate Services Department, Report No 2023-86, Nickel Beach Parking By-Law Amendments; and

Whereas Council of The Corporation of the City of Port Colborne is desirous of implementing permit parking for Nickel beach; and

Now therefore the Council of The Corporation of the City of Port Colborne enacts as follows:

1. That by-law 7006/44/22 Schedule 'A' Special Events – On-street parking permit by-law, be amended by adding thereto the following:

Nickel Beach - From Victoria Day weekend to Labour Day annually – Monday to Sunday inclusive.

2. That by-law 7006/44/22 schedule 'B' locations - On-street parking permit parking by-law be amended by adding thereto the following:
