6.2 Lodging bylaw

CAO S. Luey reported "we're so close" after five months of review by peer municipalities and legal overview. There are many grey areas between landlord and tenant in long term care. Niagara Centre MPP private member's bill to legislate and regulate supportive living residences failed second reading in provincial legislature.

S. Hanson emphasized bylaw officers can only enforce items covered in the bylaw. Concerns raised include enforcing bedbugs or other quality of life issues which impact physical and mental health which are not mandated a responsibility of Region Public Health. Committee asked CAO to contact Medical Officer of Health, and to consult City of Hamilton lodging bylaw.

A bylaw is essential, noted J. Cassan, as an avenue for action after years of front-line workers making complaints with no recourse or solution. Essential we get it right.

C. Clark-LaFleur reported food insecurity at highest levels ever. One in eight Port Colborne residents relies on Outreach Centre for groceries and meals. Recent Lions Food Drive collected 45 per cent fewer donations.

The affordable housing project is now fully enclosed, with construction of the second floor to start next week. Christine expects to deliver update to council Nov. 14.

K. Kerridge reported low-income passengers on ODSP now get a discount on cost of bus pass.
