6.1 Friday Farmer's Market, June 7th

6.3 Discussion: Marilyn Barton's proposed partnership

We can recommend she reaches out to the Learning Café, Friends over 55 or the Library.

Yes, we are advocates but we are not holding meetings for seniors to discuss their personal issues to us, CARP might be interested in hosting M. Barton.

Sloane will email M. Barton with suggestions for others to reach out to, as we are not the right fit for the proposed program.

The cause is essentially trying to support care givers and support workers, as there is no money to be had. It also takes the burdens off of the local hospitals, EMS, PSW's etc.

Long term care homes are are running out of room to accommodate and provide adequate care for clients.

CARP is non-partisan, however, if it is determined that this is what seniors need, they are more than happy to help as well.

We will add the petition to our outreach table for those interested in signing, but we will not market it as a Seniors Advisory initiative.
