



On behalf of the Friends of Roselawn, we extend our heartfelt gratitude for your generous support through the 2023 community grant we received to provide exciting creative opportunities for our community members. Your assistance has been instrumental in launching both our Art Loaning Centre and Tiny Art Library this summer at the Roselawn Centre

Thanks to our accepted government grant, we have established a vibrant space, named 'Art Loaning Centre', where community members can borrow various art supply kits. This initiative enables them to create beautiful works of art and explore new mediums that might otherwise be inaccessible. Our current offerings include poppy crocheting, watercolour painting, rock painting, and more, which have proven to be quite popular with our visitors. Guests can choose to keep their creations or donate them to our Tiny Art Library, which serves as a gallery showcasing the wonderful pieces of art produced using our supply kits, as well as any donated items from enthusiastic patrons. To encourage participation, we offer an incentive where individuals who donate their artwork can select another piece from the miniature library. This dynamic not only supports a continuous rotation of traditional and local art, but also fosters a sense of community and shared creativity among the participating citizens of Port Colborne. The Tiny Art Library has truly become a focal point where local artists and novices alike can contribute their work, creating a sparkling display of shared creativity that is celebrated and enjoyed by all.

Through the Art Loaning Centre and the Tiny Art Library, we strive to honour both the mission of the Friends of Roselawn and the historical significance of Roselawn Centre itself throughout the logistical process. For the Art Loaning Centre, we acquired a late 18th-century shelving unit originally designed for holding water buckets, which we have repurposed to display our art supplies. To pay homage to the original use of the piece, we have used similar buckets to store the kits themselves. For the Tiny Art Library, we found an ornate shelving unit at a garage sale that complements Roselawn Centre's internal and external decor, while continuing to reflect its cultural heritage through its eclectic ambience.



The crafts offered through our Art Loaning Centre have been thoughtfully chosen to highlight Port Colborne's unique energy and characteristics. For instance, rock painting, inspired by local artist Patte McCarthy, has become a particular favorite among patrons. The different crafts selected have also served as a bridge to connect various generations and backgrounds within

our community. For example, the poppy crochet kits have engaged veterans and our older residents, whereas rock painting and bracelet beading have resonated with our younger participants, reflecting broader popular cultural trends shown through social media and beyond. This intergenerational exchange has enriched our community fabric, allowing individuals to learn from one another and collaborate on shared artistic endeavors.

The response from our community has been overwhelmingly positive. Many of our



kits have circulated so frequently that we have had to replenish them with additional ones, especially the watercolour sets. This high level of engagement speaks volumes about the community's enthusiasm and eagerness to participate in creative ventures. Beyond simply providing materials, initiatives our facilitated genuine connections among community members including families, friends, and individuals from diverse backgrounds. They have the ability to come together at Roselawn Centre, sharing their artistic experiences and

fostering a deeper sense of camaraderie.

By promoting local art and traditions, we are not only preserving the cultural heritage of Port Colborne but also nurturing an inclusive environment where everyone feels welcome to contribute and celebrate their artistic talents. Your support has significantly broadened Roselawn's capacity to offer art and cultural experiences to everyone in our community. This initiative has become an integral

part of fostering togetherness and cultural enrichment within our area. We are immensely grateful for your contribution and the positive impact it has had on the members of our ever - growing community. Thank you once again for making this opportunity possible. We look forward to continuing this creative journey and expanding our reach even further.
