Dear Members,

I am writing this letter to ask that a Referendum Question be approved by Council, in order that the Citizens of Port Colborne, can have a say in the future of Health Care in Port Colborne, for their sake and their families, on the next Municipal Election Ballot.

The Hospital Building at present is a 100,000 sq. ft . certified as a functional Medical facility. It is 1/2 empty and has the ability to function as a 24/7 Urgent Care Facility .
